- Off-site pack hiking with transportation to approved trailheads. Pickup and drop-off are included.
- Hikes run Monday through Thursday. Trail, group size, and pack composition are chosen by Shanti and Me for safety.

- The client provides a properly fitted harness or collar with current tags, and a working GPS tracker. Please label your gear.

Cancellation

A minimum of 24 hours' notice is required to cancel or reschedule. Cancellations with less than 24 hours' notice are charged in full. This is how the day is planned around your dog, and how other dogs are turned away to keep the pack small.

Health and Vaccination

I certify that my dog is in good health and able to take part in car rides, trail hikes, and outdoor activity, and is current on Rabies, Bordetella, and Distemper, with tags firmly affixed. My dog is on regular parasite prevention. I will tell Shanti and Me before any hike if my dog is ill, injured, or not well enough to attend.

Behavior Disclosure
